Remarks: MUCHACHAS....WM LSW BLK POLO SHIRT/BLU JNS IS THREATENING AN EMPLOY WITH A T0 SHOWING IT OFF DUE TO THEM NOT ACCEPTING CASH....SUBJ IS SITTING RIGHT ACROSS FROM MUCHACHAS NEAR THE WALK-UP REST.

Upon arrival, the complainant identified the defendant as the person who displayed the firearm. The defendant had taken off his sport's jacket. As I made contact with the defendant, I saw the grip of a Sig P320 .45 CAL (serial # 58C059403) in the right side of his waistband unholstered. I immediately retrieved the firearm. The defendant was taken into custody. A NCIC check revealed that he did not have a concealed weapons permit.

Post Miranda, the defendant admitted that he does not have a carry concealed weapons permit. He also admitted to drinking this evening. He had a strong odor of an alcoholic beverage emitting from his breath. His eyes were glassy and bloodshot. He was unsteady on his feet.

The defendant was ID via DHSMV photo.
