THE DEFENDANT HAD TO EXIT THROUGH PASSENGER DOOR BECAUSE THE DRIVER'S DOOR WAS PINNED AGAINST THE METAL RAILING. WHILE OUT OF THE VEHICLE, HE STAGGERED AND HAD A STRONG ODOR OF AN ALCOHOLIC BEVERAGE. 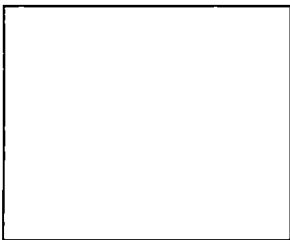
