PERSONAL CONTACT

DRIVING PATTERN: ACTUAL PHYSICAL CONTROL (PHYSICAL EVIDENCE OR STATEMENTS PUTTING DEF. BEHIND WHEEL OF VEHICLE)

On 01/25/2021 at approximately 00:26hrs, I was called to the scene of a reported suspicious vehicle driving on the Binks Country Club Golf Course under the power lines, which is located in the Village of Wellington, Palm Beach County, Florida. I arrived at the scene at approximately 00:41hrs. D/S G. Chan #32529 relayed to me, and completed a written signed sworn supplemental Probable Cause Affidavit, that he had stopped the defendant's vehicle, a 2020 silver Nissan Roque bearing FL tag LDS-P58, because the defendant was driving on private property not intended for public vehicle traffic. D/S Chan noticed that the defendant had articulable indicators of impairment, so he called for a DUI unit to conduct a possible DUI investigation. D/S Chan identified the defendant, to me, as the driver and sole occupant of the vehicle, at the time of the stop.

OBSERVATION OF DRIVER:

Upon making contact with the driver who was identified by his Ireland Driver License as "MICHAEL PAUL DUFFY", I immediately detected an obvious and very strong odor of an unknown alcoholic beverage emitting from person and face area prior to donning my PPE mask. This odor intensified as I spoke to Duffy. Duffy had glassy, glazed, and blood shot eyes. Duffy's speech was extremely slurred, slow, thick, and at times difficult to understand. Duffy's movements were slow and deliberate. Duffy was lethargic in his movements with poor coordination. Duffy had an unsteady gait while walking to my patrol vehicle and had difficulty following directions given to him. Duffy was wearing a light blue 1/s shirt, white pants, and gray shoes. All the clothing appeared soiled.

DRIVER'S STATEMENTS:

Pre-Miranda: Duffy stated he was bringing his friend home who lived on the golf course.

Duffy consented to breath and declined to participate in the Q & A portion of the interview.

ODORS:

A strong and obvious odor of an unknown alcoholic beverage was emitting from his person and face area which intensified as I spoke to Duffy.

GENERAL OBSERVATIONS

SPEECH: Duffy's speech was slurred, slow, and thick, and at times difficult to understand.

ATTITUDE: talkative, sleepy, polite, cooperative

CLOTHING: light blue 1/s shirt, white pants, and gray shoes

Other Observations:

Duffy would sway roughly in a side to side front to back pattern throughout the task. Duffy did not touch the tip of the pen as directed to positively identify the point to be tracked. Duffy was reminded numerous times to track the pen with his eyes only. Duffy failed to keep his head still while tracking the stimulus. Duffy had VGN.

WALK & TURN:

I explained and demonstrated the instructions for the "Walk & Turn" to Duffy who stated the he understood. During the task, I observed Duffy to sway roughly in a side to side, front to back pattern throughout the demonstration phase. Duffy could not maintain his balance while listening to instructions. Duffy stepped out of the instructional stance during the demonstration to catch his balance. Duffy started the task before being instructed to do so. Duffy would stop walking to steady himself with pauses to regain balance. Duffy missed heel-to-toe steps and stepped off the line. Duffy used his arms for balance by raising them more than six inches. Duffy performed an improper turn by turning other than which was demonstrated. Additionally, Duffy performed the incorrect number of steps, 12 on the return pass.

ONE LEG STAND:

I explained and demonstrated the instructions for the "One Leg Stand" to Duffy who stated that he understood. During the task, I observed Duffy to sway roughly in a side to side, front to back pattern throughout the demonstration phase. Duffy continued to sway while balancing on one leg. Duffy used his arms to balance raising them more than 6 inches from his sides. Duffy started hopping in an attempt to maintain balance. Duffy failed to count properly by thousands as instructed. Duffy put his foot down to regain balance numerous times before the 30 seconds had elapsed.

FINGER TO NOSE:

I explained and demonstrated the instructions for the "Finger to Nose" task to *** who stated that HE/SHE understood. During the task, I observed *** to sway roughly in a side to side, front to back pattern throughout the demonstration phase. *** did not keep HIS/HER eyes closed and had to be reminded numerous times. *** failed to return his/her arms down to HIS/HER sides as instructed after touching HIS/HER nose. *** index finger did not touch the nose on * of * attempts. *** searched for the tip of their nose using the finger to find their nose prior to touching the tip. *** used the hand other than that which was called. *** was unable to perform the task. The sequence used for this task was L, R, L, R, R, L.

ROMBERG ALPHABET:

I explained and demonstrated the instructions for the "Rhomberg Alphabet" task to Duffy who stated that he understood. During the task, I observed Duffy to sway roughly in a side to side, front to back pattern throughout the demonstration phase. Duffy would sway more than 2 inches. Duffy incorrectly recited the alphabet.
