THE DEFENDANT WAS THE AT FAULT DRIVER IN A TRAFFIC CRASH WHERE HE FLED THE SCENE. AT THE SAME TIME FRAME THE LARGO POLICE DEPARTMENT RECEIVED A CALL IN REFERENCE TO A DUI DRIVER IN CLOSE PROXIMITY TO WHERE THE CRASH OCCURRED. UPON OFFICERS ARRIVAL ON SCENE THEY OBSERVED THE DEFENDANT IN THE DRIVER'S SEAT OF A BLUE HONDA CIVIC BEARING FL TAG HDZA24 IN WHICH THE DEFENDANT IS ALSO A REGISTRANT OF, WITH THE VEHICLE RUNNING AND AN OPEN ALCOHOLIC BEVERAGE IN PLAIN VIEW. UPON MAKING CONTACT WITH THE DEFENDANT OFFICERS OBSERVED SEVERAL SIGNS OF IMPAIRMENT TO INCLUDE THAT HIS BALANCE WAS UNSTEADY AND HE WOULD STAGGER, STUMBLE, AND LEAN AGAINST THE VEHICLE WHILE STANDING. HIS EYES WERE BLOOD SHOT, WATERY, AND GLOSSY AND THERE WAS AN OBVIOUS ODOR OF AN ALCOHOLIC BEVERAGE COMING FROM HIS MOUTH THAT WOULD GROW STRONGER WHEN HE SPOKE. THE DEFENDANT DID CONDUCT SFE'S IN WHICH HE DISPLAYED SEVERAL MORE SIGNS OF IMPAIRMENT. POST MIRANDA THE DEFENDANT ADMITTED TO CONSUMING ONE SHOT OF BOURBON AND ONE BEER PRIOR TO DRIVING. HE WAS ALSO IDENTIFIED BY AN INDEPENDENT WITNESS AS THE DRIVER IN THE TRAFFIC CRASH.

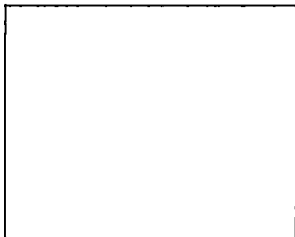
