I observed the defendant driving a silver Toyota pickup with FL tag 1TND33 on the roadway. He was speeding, 50 miles per hour in a 30 mile per hour zone. I visually estimated his speed and paced with the calibrated speedometer in vehicle #5050. I conducted a traffic stop and made contact with the defendant who was in the driver's seat. Upon contact with the defendant I could smell the odor of alcoholic beverages coming from his breath as he spoke to me. His eyes were glassy and bloodshot. He said he had a couple of beers. He performed field sobriety exercises and showed impairment. Post arrest I advised him of implied consent and he understood and refused to provide a breath sample.
