The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did Defendant and Victim have been residing together and in an intimate relationship since June of 2020. They have no children in common. On above date and time, per the sworn statements of eyewitnesses Lisa Martinez and Beck, the Defendant did use some type of force (either push or punch) to shove the Victim to the ground inside the listed address, after a heated argument. Per the sworn statement of eyewitness Adrian Martinez, he observed the Defendant push the Victim to the ground outside the listed address near the driveway, after the incident that occurred inside. Both subjects had been drinking at a bar and at listed residence for a few hours and both appeared inebriated. The Victim refused any medical treatment and made no statements she had been injured. Affiants did not observe any injuries on either subject. Victim refused to be interviewed on scene and did not want the Defendant to be arrested. Defendant refused to make any statement on scene regarding the incident and evoked his right to remain silent. The Defendant was positively identified by the listed eyewitnesses as the suspect, who committed this crime against the Victim.
