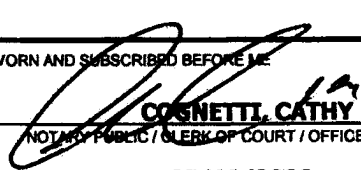
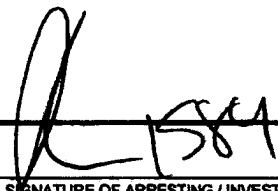

On March 22, 2022, an electronic service provider reported that one of their users, mikhenn22, phone number 561-567-4328 had saved, shared, or uploaded 2 files to other users that depicted the sexual abuse of children. The following are the files that were saved, shared, or uploaded to other users: FILENAME: mikhenn22-None-a8a37c2f-8513-5cad-88eb-bbd608337ff8-15-c738580eaf.jpg. The image depicts two prepubescent female children sitting on top of a brown couch. Both children have t-shirts and are not wearing underwear. The female children are exposing her vaginas with their legs spread open. FILENAME: mikhenn22-None-a8a37c2f-8513-5cad-88eb-bbd608337ff8-10-86f3924d0a.mp4. This video depicts a 48 second video of a naked adult male engaging in sexual intercourse with a prepubescent female child laying naked on a bed. Detective Cognetti requested the Palm Beach County State Attorney's Office to issue a subpoena for the customer assigned the IP addresses at the time the images were uploaded. I received subpoena results from Comcast for the IP Address. The Comcast account is currently active for subscriber Michael Henn with a service and billing address of 2005 Broward Avenue, West Palm Beach, Florida. Utilizing various Law Enforcement Databases I located Michael Robert Henn, DOB 05-28-1987, residing at 2005 Broward Avenue (Upper) West Palm Beach, Florida.

On April 29th, 2022, Honorable Judge Kathleen Kroll granted the residential search warrant for the address of 2005 Broward Avenue (Upper), West Palm Beach, Florida. On May 9th, 2022, the West Palm Beach SWAT team, and West Palm Beach Police Department executed the residential search warrant at 2005 Broward Avenue (Upper), West Palm Beach, Florida. Upon arrival, Det Cognetti and I spoke to Michael Henn. During a recorded post Miranda interview, Henn provided his phone number of 561-567-4328, which is the same phone number Snapchat provided on the account. Henn stated he owns and is the sole user of an Android cellular telephone. Henn stated he used the Snapchat account "mikehenn22" when he downloaded child pornography, then uploaded the child pornography. Henn stated Snapchat deactivated the account "mikehenn22" approximately 2 months ago at which time he created a new account. I presented 2 sanitized images that were uploaded saved or shared to other users. Henn signed the images indicating those were the files that he received and uploaded. An on scene preview of Henn cell phone was completed and I located 1 video and 1 image depicting child pornography. Please note that these were the same files from the cybertip. Based on the aforementioned facts, I find probable cause exists to arrest Michael Henn for 1 count of possession of child pornography FSS 827.071(5) and 1 count of transmission of child pornography FSS 847.0137(2).
