The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:
On 04-06-2021 at approximately 2020 hrs, the defendant and victim got into a dispute. During the dispute, the defendant intentionally pushed the victim. A few minutes later, the defendant grabbed the victim and threw her to the ground.
