at approximately 3:38 AM, at 5520 44TH ST N, in Pinellas County did:

WAS THEN AND THERE INTOXICATED AND CAUSED A PUBLIC DISTURBANCE, TO-WIT: DEFENDANT WAS INTOXICATED, YELLING AND CAUSING A DISTURBANCE IN THE STREETS.

LAW ENFORCEMENT WAS CALLED TO THIS LOCATION DUE TO THE DEFENDANT SHOWING UP TO HIS EMPLOYERS RESIDENCE. THE DEFENDANT WAS YELLING AND BANGING ON THE DOORS AND WINDOWS. AS DEPUTIES ARRIVED ON SCENE, WE OBSERVED THE DEFENDANT SCREAMING AND BANGING ON THE DOORS.

THE DEFENDANT REFUSED TO LEAVE THE LOCATION AND WAS DISRUPTING THE PUBLIC MORALS AND DECENCY BY CAUSING A DISTURBANCE.

THE DEFENDANT HAD THE STRONG ODOR OF AN ALCOHOLIC BEVERAGE EMANATING FROM HIS BREATH, AS WELL A BLOOD SHOT AND WATERY EYES. DEFENDANT ALSO STATED HE HAD BEEN DRINKING TONIGHT.

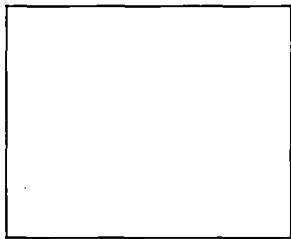
