The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did
 The defendant was arrested for DUI after being found asleep while operating his 2016 Toyota 4 Runner bearing FL tag #GLAQ28 at the intersection of S. Dale Mabry Hwy and W. Gandy Blvd. The defendant exhibited slurred speech, exaggerated movements, difficulty following directions, swayed while standing, difficulty walking, and additional signs of impairment. The defendant refused to participate in the walk and turn or one leg stand portions of the SFSE's and refused to provide a breath sample at CBT. A search incident to arrest revealed a small glass vial in the defendants right front pants pocket. The glass vial contained a white powdery residue which field tested positive as cocaine. During an inventory search of the defendant's vehicle prior to towing revealed six and a half pills located in the center console which were identified as "Adderall" which is a controlled substance requiring a prescription. There was no prescription located in the vehicle or on the defendant.

The defendant was charged with misdemeanor DUI, possession of cocaine, and possession of a prescription controlled substance without a prescription.

The defendant was identified via a valid FL DL.
