The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On listed date and time the defendant was observed operating a 2001 Chrysler Sebring bearing FL tag NMDY57 west bound on I4 at mm 12 by Dep. S. Hopp #258205. Dep. S. Hopp conducted a traffic stop and observed an open container in the vehicle and the defendant showed signs of impairment. Affiant responded to the scene to conduct a DUI investigation. Affiant read Miranda to the defendant and he waived. Affiant observed lack of smooth pursuit, distinct and sustained nystagmus at maximum deviation and onset of nystagmus prior to 45 degrees (observed at 40 degrees.) The defendant performed the walk and turn and missed heel to toe four times, stepped off the line throughout the exercise, raised his arms for balance throughout the exercise, and turned improperly. During the one leg stand exercise, he could not hold his foot up for more than 2 seconds without putting it down, used his arms for balance, and swayed throughout the exercise. The defendant was transported to CBT where he refused to provide a sample of his breath after I read him implied consent. The defendant was positively identified via valid FL DL.
