The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: On above date and time, law enforcement was dispatched to the Transfer Level of the Tampa International Airport, within Hillsborough County Florida. This was in reference to Michael William Saks (DOB 06/07/1969), defendant causing a disturbance by raising his voice to his family and around a large volume of airport passengers. The affiant made contact with the Defendant who was extremely unsteady on his feet, had slurred speech, blood shot watery eyes and the strong odor of a consumed alcoholic beverage emitting his breath, which was growing stronger. At this time, I attempted to escort the defendant down into the elevator to assist him. However, the defendant continued to become more verbally combative and unstable. This was due to him obviously being impaired beyond his normal faculties from his level of impairment. While in the elevator, the defendant began getting aggressive by growling and making furtive movements, such as clenching his fists and bowing his chest towards affiant. Upon exiting the elevator, the defendant continued the same actions and began walking towards be in an aggressive manner with his arms down at his sides with his fist clenched together, yelling, "Fuck you, we can fucking go", "I don't care if your 6'2". At this time the defendant was escorted to the ground safely per policy and procedure and was subsequently placed under arrest and charged accordingly.
