On 5/6/2022, at approximately 0705 hours, I arrived at, 1432 Lake Breeze Dr, Wellington FL, to investigate a domestic dispute complaint. I spoke with Carmen Duran, who told me the following in a sworn statement. Mrs. Duran was involved in a heated verbal argument with her husband, Michael Zakarian. During this argument Mr. Zakarian punched her in the head and slammed the bedroom door on her forehead. I did observe a mark on both Mrs. Duran's forehead and bedroom door consistent with her version of events. Mrs. Duran also had a scratch to her wrist sustained during the altercation but couldn't explain. Mr. Duran denied punching his wife in the head and said she was the one who slammed her own head in the door causing her injury and damage to the door. I also spoke with Mrs. Duran's daughter, Devyn Duran, who said she didn't see what exactly took place but could confirm a loud argument and her mother yelling for help. Based on sworn statements and physical evidence, Mr. Zakarian was arrest and charged with battery (domestic) in violation of FSS 784.03 1A1.
