The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did. On 01/01/2021, at approximately 2157 hours, I responded to Pebble Beach Bl S. and New Bedford Dr. Sun City Center, Fl. 33573 to assist Deputy Strahan(ABN:258675) with a reckless driver call for service. Call notes related that a female with blonde hair smelled strongly of alcohol and was slurring her words. Also the female was driving a vehicle with license plate:6703YP. Deputy Strahan located the vehicle in an alley and with the lights on. Deputy Strahan conducted a consensual encounter with the defendant. When he made contact with the defendant, who was in the driver's seat of the vehicle, he observed her to have indicators of impairment and to have the keys to the vehicle in her hands. When I made contact with the defendant, I observed her to have watery/glassy eyes, slurred speech, unstable on her feet, and I smelled the odor of an alcoholic beverage emitting from her breath. The defendant elected to perform the standardized field sobriety exercises, and doing so, I observed more indicators of impairment. At Central Breath Testing, at Orient Road Jail, the defendant refused to provide lawful breath samples by repeating "I want to call my lawyer" before and during implied consent. The defendant was identified via Florida driver's license.
