PERSONAL CONTACT

DRIVING PATTERN: (Actual Physical Control; Physical Evidence or Statements Putting Defendant Behind Wheel of Vehicle)

On 07/09/2021 at approximately 0035 hours, This Officer was on patrol in the area of Alt A1A and Donald Ross Rd, PBG, FL, when a vehicle was observed traveling south bound outside through lane and drifting. Body worn camera and in car video were used.

This Officer observed the Jeep (1TW095/FL) drift over the striped lines to the left and fog line to the right multiple times. This Officer also observed the vehicle increase and decrease in speed with no traffic nor any other obstructions to the front. This Officer's initial visual estimation of the vehicle, was approximately 70 MPH in a posted 50 MPH zone. Using RADAR Stalker DMR2X (DM001317), front antenna (EC086606) this Officer received a steady tone and reading of 68 MPH. The RADAR calibration was last checked on 05/27/2021 and was due on 11/27/2021. Prior to this tour of duty on this date, this Officer ensured the RADAR was in working order, to confirm the accuracy of the unit. At the end of this tour of duty, this Officer did the same. This Officer received RADAR/LIDAR certification on 05/31/2008, in Cannon AFB, MN. This Officer initiated a traffic stop on the vehicle in the 4100 block of Hood Rd, PBG, FL. This Officer made contact with the driver and sole occupant of the vehicle, identified via Florida Driver License photo, Michelle Morris, while she was still in actual physical control of the vehicle.

OBSERVATION OF DRIVER:

Morris had a slow slurred speech, bloodshot watery eyes, flushed red face almost to the point of sweating, and the strong obvious odor of an unknown alcoholic beverage emanating from her breath. This odor increased in intensity as Morris spoke with this Officer. Morris had difficulty locating the requested documents after looking through paperwork. Morris ultimately did not provide all requested documentation.

DRIVER STATEMENTS:

Morris said she was coming from a friend's house and was on her way home. Morris denied consuming alcoholic beverages on this night. Morris' response to where she was coming from, was delayed.

Other Observations:

Morris had to be told multiple times to follow instructions. Morris would look at this Officer or anticipate the movement of the stimulus. At one point Morris rolled her eyes and also put her hands in her pockets. Morris was also swaying back and forth during the exercise.

Walk and Turn

During the instructions, Morris had difficulty getting into and remaining in the starting position. Morris also started prior to being told to do so. Morris then said she would not normally be able to do the exercise and mentioned not being able to do it in Pilates. This Officer concluded the exercise at this time. Morris then used the same reasoning regarding the One-Leg Stand exercise and said she had bad ankles, thus that exercise was not conducted as well.

Finger to Nose

This Officer told Morris to look up and close her eyes. Morris did not look up and then said she was unable to do the exercise. This Officer then advised Morris of her Taylor Warnings, to which she acknowledged and agreed to continue. During the exercise the follow observations were made: The first command of left and right respectively, Morris touched the side of her nose with the pad of her finger. Second command of left, Morris searched then used the pad of her finger. Second command of right, Morris hesitated and used the pad of her finger. Third command of right, Morris raised her left hand then her right and used the pad of her finger. Final command of left, Morris touched under her nose with the pad of her finger. During all six commands, Morris had to be told to lower her hand.

Rhomborg

Once told to begin, Morris asked if she should count aloud, to which this Officer again explained the exercise and started it over. Morris estimated the passage of 30 seconds in approximately 26 seconds.

Alphabet

During the exercise Morris stated A through H then opened her eyes and looked at this Officer. Morris then said "I just did this with my niece and she had issues". Morris then started over and again quickly recited A through H, then G, I, F and trailed off. Morris was then placed under arrest.

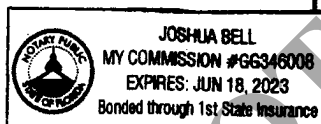
