The undersigned certifies and swears that he/she has just and reasonable grounds to believe, and does believe that the above named Defendant committed the following violation of law... committed the below acts in my presence... confessed to MOLLIE RYCKMAN... On the 5 day of SEPTEMBER 20 20 at 2:45 P.M.

I was dispatched to 1466 Hippocrates way, West Palm Beach, FL in reference to a shoplifting in progress call. Upon my arrival I met with manager Mollie Ryckman who advised me that a female who stole from the store on 8/22/2020, was back and currently stealing again. I then made my way towards the store and met with a female identified as Mindy Goldberg, who Ryckman identified as the female who was stealing. I then spoke with Ryckman who advised she didn't steal anything and had just paid for the items. Goldberg handed me two bags, one personal and one from the store. Inside the personal bag was a bottle of sealed Meltaway Weight Loss product, and a store bag with paid items.

Ryckman then confronted Goldberg about the previous theft of over \$1000 Goldberg committed. I heard Goldman tell Ryckman that she did in fact steal the items prior on 8/22/2020 and that she didn't believe it was worth over \$1000. The prior theft loss on 8/22/2020 was approximately \$1200. I then made contact with store clerk Tierna Wilson who advised she witnesses Goldberg place items in her personal bag and attempt to leave the store without paying for them today on 9/5/2020. Wilson confronted Goldberg who agreed to pay for the items in her personal bag, but still stole one bottle of the Meltaway Weight Loss.

Goldberg was then placed under arrest and advised to sit on a curb near my patrol car to await being secured in a caged PBSO car. While sitting Goldberg accessed her phone, and was advised to drop all her property so I could place her in handcuffs. Goldberg refused and hid all items behind her back. I then attempted to roll Goldberg over to secure her hands and she continued to resist my efforts to secure her and obtain and secure her property. Goldberg was finally secured after several commands to provide me her hand and drop the items in her hand.

Surveillance video from the theft today on 9/5/2020 were obtained and placed into evidence as well as sworn written statements from two witnesses. The theft which occurred on 8/22/2020 already had submitted statements and video surveillance.
