The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On 02/4/2021 a Tampa Police Officer responded with a Department of Children and Families Child Protective Investigator to the victim's school (Foster Elementary) in reference to a report of possible physical abuse. Upon interviewing the victim, he disclosed the defendant, who is the victim's mother, struck him with a belt on his arms and legs, grabbed his face and attempted to smother him with a pillow for punishment. Multiple visible injuries were observed to the victim's face, arm, and leg which caused concern. The victim's injuries included a vast amount of bruising to the left arm, and right leg, and scratch marks and bruising to the left cheek.

Your affiant later responded to the listed address to interview the defendant. Upon conducting a non-custodial interview with the defendant and confronting her with the facts on multiple bruising on the child's body, she admitted to causing the injuries while punishing the victim for bad behavior. The defendant states she has previously disciplines the victim a belt and he will move and try to run away during punishment. The defendant also stated she slapped the victim to his face causing the scratch marks, and she did put a pillow to his face while he was on the bed and only stopped when he screamed "I can't breath."

The defendant was positively identified as the person who committed the offense. The defendant was positively identified via Mexico Passport photo and RMS photo.
