The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did
 On 7/17/2020 at approximately 0110 hours, the defendant was traveling southbound on Falkenburg Rd at a high rate of speed in a white Jeep Cherokee bearing FL tag 565NJB (VIN: 1J4FT48S21L516515). The defendant increased his speed after I activated my emergency equipment in an attempt to elude me. The defendant ran through a solid red light at the intersection of Falkenburg Rd and Causeway Bl. then continued to accelerate over 100 mph. Cpl Dobson observed the vehicle traveling westbound on Lumsden Rd and was able to capture the speed on his radar at 111 mph (see citation ADT92DE). Upon Cpl Dobson's contact with the driver he observed indicators of impairment. Upon my arrival, I observed the defendant to have bloodshot watery eyes and slurred speech, along with the odor of an alcoholic beverage emitting from his breath. Upon the defendant's completion of SFSE's he displayed several more indicators of impairment. Once at CBT, the defendant provided 2 lawful breath samples of 0.128/0.123% BrAC, after a 20 minute observation period. During a search of the defendant's person, 2 bags of green leafy substance were found within his right front pants pocket and a small plastic bag with a white powdery substance found in his right front coin pocket. The green leafy substance tested positive for THC and was identified as Marijuana by the defendant, also the defendant identified the white powder to be Cocaine and tested positive as Cocaine. Both substances were tested with HCSO issued field reagent test kits. The defendant was issued DUI citation A850J7E and other citations for speeding, running steady red light and UTC ADT95PE for fleeing to elude. The defendant identified himself via FL DL.
