The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: The defendant was driving a 2014 silver Dodge Ram bearing a Florida license plate of PZWN71. He was traveling east on Kennedy Blvd at MacDill Ave and caused a traffic crash when he failed to maintain a single lane, left the roadway, and struck a large tree on the shoulder of the road causing about \$500 in damage. This affiant witnessed the traffic crash and the defendant was positively identified as the driver. Upon making contact with the defendant he displayed multiple indicators of impairment, to include; watery and bloodshot eyes, slurred speech, an odor of an alcoholic beverage, unsteady stance, and an admission to consuming alcohol. The defendant performed SFSEs and multiple clues of impairment were observed. The defendant was arrested for DUI and later submitted to a breath test which had a BrAC result of .121 and .127. The defendant was identified by his FL DL.
