The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: On the above-listed date and time, Sergeant H. Gross #5751 conducted a traffic stop on a gray Ford pickup, bearing Florida tag LYNP02 (VIN: 1FTEW1EP9JKD50457). Upon contact with the driver, defendant and sole occupant of the driver, Sergeant Gross detected signs of impairment. The affiant responded and detected signs of impairment on the defendant, which were bloodshot watery eyes and the distinct odor of an alcoholic beverage emitting from his breath. The defendant performed Standard Field Sobriety Exercises (SFSEs), which the defendant agreed to do. During the SFSEs, the defendant performed them poorly indicating signs of impairment. While en-route to Central Breath Testing (CBT), the defendant was inquiring about the affiant's residence, full name, and general information while making threats to harm and or kill the affiant and his respected family. The defendant then stated, "I will murder you.", which was all captured via affiant in-car camera. The defendant refused to provide a lawful breath sample after Implied Consent warning was read and understood. The defendant was issued DUI citation AA2S50E, which reflects the charge. The defendant was identified by his Florida Drivers License.
