at approximately 3:59 PM, at 2738 ROOSEVELT BLVD #201, in Pinellas County did:

DID INTENTIONALLY OR KNOWINGLY TOUCH OR STRIKE, A PREGNANT PERSON, AGAINST THE WILL OF AMAL OMAR HULWE AND AT THE TIME OF THE BATTERY THE DEFENDANT KNEW OR SHOULD HAVE KNOWN THAT THE VICTIM WAS PREGNANT.

DEFENDANT IS THE FATHER OF THE BABY THAT VICTIM IS EXPECTING. VICTIM'S 9YOA DAUGHTER WAS PRESENT IN THE ROOM, WHEN SHE OBSERVED DEFENDANT HITTING VICTIM ON THE FACE WITH A CLOSE FIST, THEN VICTIM DEFENDED HERSELF AND HIT HIM BACK. VICTIM ADVISED THAT DEFENDANT HIT HER FIRST TODAY IN HER CHEST IN THE PUBIX OF EAST BAY DR, THEN AFTER THE ARGUMENT HE HIT HER ON THE LEFT SIDE OF HER FACE, SHE DEFENDED HERSELF AND DURING THE STRUGGLE, SHE BIT HIM ON THE BACK OF HIS NECK SO HE WOULD STOP HIS AGGRESSION. POST MIRANDA DEFENDANT SAID THAT SHE HIT HIM, FOR NO REASON AND THAT HE DID NOT WANT TO FILE CHARGES. HE ALSO ADVISED ME THAT VICTIM IS PREGNANT WITH HIS BABY. 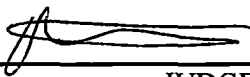
ADVISORY AND SOLVENCY HEARING

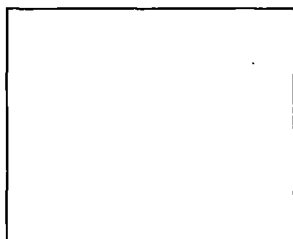
