The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:
 On 04/04/2021, at approximately 2125 hours, in the front yard of a residential home which is located at 10824 Palmetto Street, Riverview, Florida 33569 the victim/witness observed a white Hispanic female/defendant exiting a white 2018 Nissan Rouge bearing Florida tag FD2861 with an assigned VIN of JN8AT2MT2JW491007 immediately following a traffic crash. Upon the arrival of law enforcement, the deputies observed multiple indicators of impairment from the defendant. Deputy D. Lott ABN: 232457 responded to the scene and completed a traffic crash investigation (#89441315-01/21-217393). Upon the affiant's contact with the defendant, I observed her to have slurred/delayed speech, she was unsteady on her feet, her eyes were watery glassy, and I smelled the strong odor of an acholic beverage emitting from her breath. The defendant participated in field sobriety exercises and while doing so, she demonstrated further indicators of impairment. After taking the totality of the circumstance and the defendant's indicators of impairment into consideration, she was placed under arrest for DUI. The defendant was transported to Central Breath Testing and she was read Implied Consent. After the defendant's further consideration, she provided two lawful breath samples of .153 and .145. As a direct result of this crash the defendant caused approximately \$9,000 of property damage. The defendant identified herself verbally. I further identified the defendant via her David Photograph.
