The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did
 Ofc J. Gonzalez made contact with the defendant, who was identified by her Florida Driver's License, after she drove her vehicle around a police barricade and entered a section of 17th St. N. which was closed for traffic. The defendant had watery eyes and a strong odor of an alcoholic beverage emitting from her breath. Defendant had difficulty following instructions, and when she exited her vehicle she was unsteady on her feet and swayed back and forth. Defendant had 6 point Nystagmus when she was administered the HGN. While awaiting my arrival, the defendant vomited on herself. I administered the defendant additional SFST's, all of which she displayed extreme difficulty in performing. Defendant was arrested for DUI and was transported to CBT where she was administered a breath test. Defendant's BrAC measured .147 / .151 This occurred in Hillsborough County, Florida.
