(Specifically include facts constituting cause for arrest.)</p> <p>On October 19, 2019, at approximately 18:19 I responded to 49 Bedford B, West Palm Beach, Palm Beach County, FL 33417 in reference to an assault. According to the call, the complainant stated the mother of the child she babysits came into her home and pushed her.</p> <p>Upon arrival, I met with the complainant Bonita Johnson who stated to me that she is the baby sitter for the child of Monika Berki. Johnson stated that Berki cannot come to her home and take possession of the children per court order; however she is allowed to come to the residence only to say hello. Today Johnson said Berki's mother came by her residence and was knocking on the door but she did not answer it because she always causes trouble and is scared to get in an altercation with her daughter Berki. Johnson informed me that later in the day she ordered pizza for herself, her granddaughter and the daughter of Berki. When the pizza man showed up Johnson opened the door to pay for the pizza, but Berki was right behind the pizza man and shoved her way into Johnson's home. Johnson stated that she tried to tell her to get out but Berki pushed her way in and then pushed Johnson which caused her to hit her leg on the wall which caused a minor laceration and then stepped on her foot bruising it. Johnson then stated Berki was screaming at her in her home saying "hit me", Johnson then grabbed her phone and stated she was going to call the police. Johnson told me that Berki grabbed her hand and tried to stop her from calling the police and would not let go of her hand. Johnson was able to break loose and get Berki out of her home. Johnson said this is the third time Berki has shown up to her residence and caused an issue and has reported similar incidents but could not provide me with the case numbers. Johnson stated to me that the pizza man is a witness and he would share his information with us. Johnson said she is in fear that Berki will continue to show up to her home and harass her. Johnson has no relation to either party as she is just the babysitter.</p> <p>I also met with Berki who stated to me that she went to Johnson's home and knocked on the door. When Johnson opened the door Berki saw her kid and picked her up to say hello. Berki and Johnson then got into an argument and Berki stated Johnson was screaming in her face saying "get out of my house" Berki said Johnson then pushed her daughter in the shoulder area and forced Berki to leave. When I asked Berki if she pushed Johnson or tried to interfere with her calling the police she told me none of that happened. I asked Berki if she would like to fill out a sworn written statement which she refused at the time and said she was not calm enough to write one and wanted a counselor to help her with the statement.</p> <p>I then relocated to Paisano's Pizza located at 5926 Okeechobee Blvd, West Palm Beach, FL 33417 to further my investigation by speaking with the witness. Upon my arrival to the business, I made contact with an adult aged white male, who identified himself as being the witness to the incident named Frank Melillo. Melillo explained that he had been delivering a pizza to Johnson's residence, when Berki walked up beside him, opened up the door to the residence, and entered into the residence uninvited. Melillo stated Berki began to yell at Johnson for a couple of minutes and tried to take Johnson's cellphone when she attempted to contact the police for assistance. He stated that Berki then made her hand into a fist, placed it in the air like she was going to strike Johnson. Melillo stated that he feared that Berki was going to actually strike Johnson with her closed fist, so he intervened by yelling "hey lady" which caused Berki to place her fist down and leave the residence. I asked Melillo if he saw Johnson push the child forcefully when Berki was in the residence and he stated she had no intentions of pushing the child in a harmful way, and that she had just put her arm back in a way to keep her from running into the altercation or out of the residence's open front door.</p> <p>Johnson and Melillo both completed PBSO sworn written statements detailing their accounts of the incident. Due to Johnson and Melillo's statements being consistent with each other, as well as my observation of injury on Johnson, I found probable cause existed to arrest Berki for committing the criminal offenses of Preventing Communication with a LEO (Witness Tampering) FSS 914.22(1)(e). Burglary to a Occupied Dwelling FSS 810.02(3)(a) and Battery Victim >65 FSS 784.08(2)(c) against Johnson.</p>
