




<p>MVR available.</p> <p>On 07/08/2021 at approximately 0040 hours, I responded to the area of 1300 NW 2nd Ave to assist BRPD Ofc. Baron on a traffic stop. Ofc. Baron informed me that he had observed the driver of the vehicle, later identified as Morgan Cooper, driving in the bicycle lane and failing to maintain a single lane while traveling northbound on N Federal Hwy. Ofc. Baron informed me that Cooper advised the moving violations observed were a result of him being tired.</p> <p>Upon my arrival, Ofc. Baron ordered Cooper to exit his vehicle. I asked Cooper if he had been drinking and he said he had not. Cooper informed me that he had just left the Cigar Bar and was on his way to West Boca where he resides. Cooper also informed me that he is prescribed Adderall and had taken it earlier, but he could not advise when. I stated to Berkley that I was concerned that he may be driving while impaired and asked if he would be willing to submit to Standardized Field Sobriety Tasks to dispel my alarm that he may be impaired. Cooper agreed to submit to the Field Sobriety Tasks. I first asked Cooper if he had cataracts, other eye problems, diabetes, or any other physical condition that may affect his balance or ability to walk, to which Cooper replied he did not. Cooper was also wearing comfortable tennis shoes. I then proceeded with the Field Sobriety Tasks.</p> <p>Cooper performed the One-legged Stand. During this exercise, he failed to maintain his balance and placed his foot down on the ground multiple times. Cooper also performed the Walk and Turn exercise. During this exercise, Cooper took ten steps one way and ten steps the other way instead of taking nine steps as he was instructed. Cooper also failed to turn around using a series of small steps as instructed. Cooper also paused during the exercise and stated that his shoe might be untied. Cooper also performed the Finger to Nose exercise. During this exercise, Cooper's index fingers did not touch the</p>




<p>tip of his nose each time as was demonstrated for him.</p> <p>Based upon the totality of the circumstances, including Ofc. Baron's observation of Cooper's moving violations while operating his vehicle, my observations of Berkley's performance of the Standardized Field Sobriety Tasks, and Cooper's inability to follow instructions consistently, I determined that Cooper was driving while impaired by alcohol or other chemical substance. I placed Cooper under arrest for DUI per F.S.S. 316.193(1A). Subsequent to his arrest, Cooper reiterated that he had not been drinking. I informed Cooper that my observations indicated that he was impaired by some sort of chemical, to which Cooper replied that it could be the Adderall.</p> <p>Berkley was transported to PBSO RAT, where he blew .000 and .000 into the Intoxilyzer 8000. Daly that Morgan Cooper was contacted by the Palm Beach County Clerk of Courts and notified that a warrant was out for his arrest for missing a supposed scheduled court date of 08/03/2021. After reviewing my arrest packet, I discovered that this was a misunderstanding on the Rough Arrest form which I submitted in my arrest packet.</p> <p>In the Notice to Appear block on Cooper's Rough Arrest form, the box is checked which states that he need not appear in court. However, it appears that the date of 08/03/2021 populated in the date block in error, causing the misunderstanding. Mr. Cooper was in fact not required to appear in court on 08/03/2021. The only court appearance which he is obligated to fulfill for this case is the date of 08/10/2021, as is shown on his Uniform Traffic Citation ADR5WFE. Based upon the context of the Palm Beach County Clerk's email sent to Cooper, the clerk's office seems to have mistaken the rough arrest form for a notice to appear.</p> <p>I called Cooper and informed him of the situation and the misunderstanding. I also told him that I would contact the Palm Beach County Clerk of Courts during business hours to clarify the situation to them. I then emailed court specialist Rachel Francois Dieujuste with the Palm Beach Couty Clerk's Office and informed her in detail of the situation. Sgt. Daly also informed me that BRPD Dispatch ran a check of Cooper's criminal history with negative results for any active warrants as of 08/05/2021.</p>
