The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:

The defendant was driving a 2015 white Chevy Tahoe bearing a Florida license plate of DGWE31. She was traveling north on N Howard Ave between W Kennedy Blvd and I-275 and was traveling at 68 MPH in a posted 40 MPH zone. This was paced with my calibrated vehicle, #113. In addition, the defendant ran a steady red light at Cypress Blvd without slowing down. I also observed the vehicle weaving back and forth and struck the curb. A traffic stop was made and the defendant turned onto the I-275 on ramp and pulled to the shoulder eventually striking the cement wall. Upon making contact with the defendant she displayed multiple indicators of impairment, to include; watery and bloodshot eyes, droopy eyelids, slurred speech, an odor of an alcoholic beverage, and an admission to consuming three alcoholic beverages. The defendant performed SFSEs and multiple clues of impairment were observed. The defendant was arrested for DUI and later refused to submit to a breath test, despite acknowledgment of the Implied Consent Warning.

The defendant was identified by her FL DL.
