NARRATIVE:

I am part of a National Task Force known as the South Florida Internet Crimes Against Children (ICAC). This task force investigates internet crimes against children, child exploitation, and related cases.

On 10/25/2019, I was assigned to further investigate a Cyber Tip report #55696828 from the National Center of Missing and Exploited Children (NCMEC) concerning images of child pornography being forwarded from the Broward County Sheriff's Office South Florida Internet Crimes Against Children Task Force. The Cybertip was reported by MeWe. MeWe reported to NCMEC that four images depicting apparent child pornography were uploaded by user "Avery Hewe".

Cybertips are investigative leads generated by NCMEC. NCMEC is a non-profit organization that provides services nationwide for families and professionals in the prevention of abducted, endangered, and sexually exploited children. Pursuant to its mission and its congressional authorization (42 USC 5773) NCMEC operates the CyberTipline and Child Victim Identification Programs to assist law enforcement in identifying victims of child pornography and child sexual exploitation. NCMEC works with law enforcement, Internet Service Providers, electronic payment service providers, and others to reduce the distribution of child sexual exploitation images and videos over the Internet. NCMEC forwards reports of child sexual exploitation to law enforcement for the purposes of investigation and disposition.

According to the cybertip, the incident occurred on 04/10/2019 at 01:04:00 UTC. MeWe did not report an IP address during the date of occurrence, but captured IP address 76.110.195.184 on 09/18/2019 at 22:29:00 UTC.

On this same date, I reviewed the image files:

FILENAME: SCREEN SHOT 2019-09-18 AT 3.38.48 PM.PNG

This image file depicts a white female child, approximately 7-9 years of age, laying on a red blanket while nude. The child's breasts and vagina are exposed to the camera.

FILENAME: SCREEN SHOT 2019-09-18 AT 3.38.36 PM.PNG

This image file depicts a white female child, approximately 8-10 years of age with a sports bra on and no pants. The child is sitting down with her legs spread open. Her vagina is exposed to the camera.

FILENAME: SCREEN SHOT 2019-09-18 AT 3.38.22 PM.PNG

This image file depicts two white females nude on a bed. One of the females is lying down and appears to be of pubescent age due to hair that is visible on her vagina. The other female (approximately 10-12 years of age) is sitting next to the female who is lying down and she has her hand next to the pubescent female's vagina.

FILENAME: SCREEN SHOT 2019-09-18 AT 3.37.58 PM.PNG

This image file depicts a white female child, approximately 4-7 years of age, who is nude and lying down. There is an adult white male's penis visible in the photo and it appears as though he has just ejaculated on the child's stomach.

On October 29, 2019 I served a subpoena on Comcast who is the service provider for the IP addresses captured by MeWe. On this same date I received records from Comcast which indicated that the subscriber for the IP address is Berta Hewey with an address of 5832 Midland Avenue, Greenacres, FL.

A check of the Florida's Driver's License database revealed a record for a [REDACTED]. I then conducted a search of the address through the same database and it revealed three males with this same address, one of which being Murray Avery Hewey. This name was significant as the MeWe username was "Avery Hewe".

Through investigation, I was also able to find two police reports dated 02/12/2016 and 06/19/2014 wherein phone number 561-779-1977 is listed as the contact number for Murray A. Hewey, DOB 08/31/1964.

A subpoena was served on T-Mobile for subscriber information on phone number 561-779-1977. On December 3, 2019 I received the subpoenaed records from T-Mobile which revealed that the subscriber is Murray Hewey at the same address in Greenacres, FL. The account activation date is listed as 12/29/2016 and the phone model is listed as "SAM CORE PRIME WH TMUS KIT RSU".

On March 3, 2020 I made contact with MeWe and they were able to confirm that the phone number associated with the account was verified. MeWe advised that when the account is set up, they send a 6-digit code to the user's phone which they then have to enter on the application to activate their account.

On March 13, 2020, a search warrant was served on MeWe for all content in the account of "Avery Hewe".

On March 16, 2020 I received records from MeWe in response to the search warrant that was served. Included in the production were the following files and documents:

Upon looking up the profile image id in the photo file, it was discovered that it was a photo of Murray Hewey taken at a bar. I was able to identify Murray Hewey in this photograph based on his driver's license photo.

I then reviewed the MeWe User Chat document which contained all of the chat content from the reported users side of the conversation. The recipients of the messages are listed by their user id, but their side of the conversation was not provided. In reviewing these chats I found multiple images of child pornography that "Avery Hewe" sent to other users as well as references to the sexual abuse of family members.

I also reviewed 8 Video files that the user shared on the MeWe platform which were found to contain sexually explicit content involving children.

On May 8, 2020 a search warrant for Hewey's residence was signed by the Honorable Judge Sarah Willis.

On May 13, 2020 Det. Wildove and I made contact with Murray Hewey at his residence. Det. Wildove and I attempted to speak with Hewey on the back patio of his residence, but after reading him his Miranda warnings he indicated that he did not want to speak and needed an attorney.

Det. Fay conducted an on-scene forensic analysis of several devices that belong to Hewey. The on-scene analysis revealed the following a video of a white female, approximately 7-10 years of age, who is masturbating and then appears to insert a writing pen into her vagina. Also found were 5 images depicting child pornography to include a white female, approximately 7-10 years of age, who has no pants on and is kneeling over top of a sex toy shaped like a man's penis. The sex toy appears to be inserted into her vagina

The analysis also revealed search terms of "pthc", "pedo", "lolita", "6yo", and "8yo". Based on my training and experience I know that "pthc" stands for pre-teen hard core" and that "yo" refers to years old, so in this case, 6 years old and 8 years old. I also know from my training and experience that "pedo" refers to pedophilia.

Based on my investigation, there is probable cause to believe that Murray Hewey did intentionally transmit images on the MeWe platform which depict child pornography and that he was still in possession of images depicting child pornography upon execution of the search warrant, which are violations of Florida State Statutes 827.071 (5) and 847.0137(2).
