The undersigned swears that he/she has reasonable grounds to believe that the above named defendant on the 05 day of DECEMBER, 2019, at approximately 10:45 PM, at 10410 SEMINOLE BLVD, in Pinellas County did:

THEN AND THERE UNLAWFULLY DRIVE AND/OR BE IN ACTUAL PHYSICAL CONTROL OF A MOTOR VEHICLE WITHIN PINELLAS COUNTY, FLORIDA WHILE UNDER THE INFLUENCE OF AN ALCOHOLIC BEVERAGE, A CONTROLLED SUBSTANCE AND/OR ANY CHEMICAL SUBSTANCE TO THE EXTENT THAT HER NORMAL FACULTIES WERE IMPAIRED.

REASON FOR STOP: DEPUTY SKALKO INITIATED A TRAFFIC STOP ON THE VEHICLE THE DEFENDANT WAS OPERATING AFTER OBSERVING IT MAKE A NORTHBOUND TURN FROM 104TH AVE. N., ONTO SEMINOLE BLVD. WHILE MAKING THE TURN, DEPUTY SKALKO OBSERVED THE DEFENDANT FAIL TO KEEP HER VEHICLE AS CLOSE AS PRACTICABLE TO THE RIGHT-HAND CURB, OR EDGE OF THE ROADWAY, AS POSSIBLE. THE DEFENDANT ENTERED THE ROADWAY BY TURNING INTO THE MEDIAN LANE, NEARLY STRIKING THE MEDIAN. DEPUTY SKALKO ADVISED THE DEFENDANT FAILED TO YIELD TO ONCOMING TRAFFIC WHEN IT ENTERED SEMINOLE BLVD., AS WELL.

DEPUTY SKALKO INITIATED A TRAFFIC STOP ON THE VEHICLE AND MADE CONTACT WITH THE DEFENDANT. UPON MAKING CONTACT WITH THE DEFENDANT, DEPUTY SKALKO OBSERVED HER TO SHOW SIGNS OF IMPAIRMENT, PROMPTING HIM TO REQUEST A DUI UNIT TO INVESTIGATE FURTHER.

UPON MY ARRIVAL, I MADE CONTACT WITH THE DEFENDANT AND I OBSERVED HER TO SHOW SIGNS OF IMPAIRMENT, PROMPTING ME TO REQUEST HER TO PERFORM STANDARDIZED FIELD SOBRIETY EXERCISES. THE DEFENDANT PERFORMED SFSE'S AND I CONTINUED TO OBSERVE HER TO SHOW SIGNS OF IMPAIRMENT.

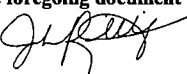

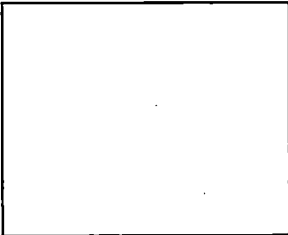
