At the time, I was driving an unmarked Jupiter Police Department patrol vehicle (vehicle 1308), I was wearing a JPD uniform clearly identifying myself as a Jupiter Police officer, and I was wearing my department-issued Axon body camera.</p> <p>Upon arrival, I observed a white 2020 Lexus SUV bearing FL tag # PGXB70 stopped, facing south, in the west side of the parking lot. I observed the front driver window of the vehicle was smashed out and there was a female, later identified as Naomia McCullough (w/f; 02/08/1980), sitting in the driver seat.</p> <p>I made contact with PFC Kolenich who advised he was conducting routine patrols when he observed the aforementioned vehicle drive over the concrete median and almost strike his vehicle from the rear. PFC Kolenich activated his overhead emergency lights and siren at the intersection of S.R. 706 (W Indiantown Rd.) and S.R. 811 (N Alternate 1A) as the vehicle traveled westbound. PFC Kolenich followed behind the vehicle attempting to pull it over for several blocks. The vehicle passed multiple parking lots and roadways to pull over and continued to the parking lot of 439 W Indiantown Rd. before it came to a stop. PFC Kolenich identified the driver as McCullough by her valid Class E Florida driver license.</p> <p>I walked up to the shattered driver's window and made contact with McCullough. I immediately observed McCullough had bloodshot/glassy eyes and heavily slurred speech. I could smell the strong odor of an unknown alcoholic beverage on McCullough's breath which intensified as she spoke. McCullough stepped out of the vehicle at my request and multiple pieces of shattered glass fell out of her lap onto the roadway. McCullough demanded I provide my first name to her and began insisting that I had allegedly asked</p>

<p>her questions which I did not.</p> <p>McCullough advised she does not have any medical conditions and did not take any medications. McCullough advised she has a lazy eye and showed me. I observed McCullough had apparently full range of motion in her right eye but her left eye more or less stayed fixated straight ahead. I requested McCullough complete Standardized Field Sobriety Tasks (SFSTs) and she agreed.</p> <p>I first conducted the Horizontal Gaze Nystagmus task. I am a certified Drug Recognition Expert (IACP # 32395) and I conducted this task in accordance with my training. I observed McCullough's pupils appeared to be of equal approximate size and she did not display resting nystagmus. McCullough was not able to equally track a moving stimulus due to her lazy eye. I observed Lack of Smooth Pursuit, Distinct and Sustained Nystagmus at Maximum Deviation, and the Onset of Nystagmus prior to 45 Degrees in McCullough's right eye. I could not observe any of the aforementioned clues in McCullough's left eye due to the fact that it remained fixated straight ahead.</p> <p>I then conducted the Walk and Turn task. McCullough had difficulty choosing one of the two white parking lane lines and stood with her left foot on the leftmost lane line and her right foot on the rightmost lane line. I demonstrated the starting position to her (standing on the line, facing her) and she stood appropriately. During the Instructions Stage, McCullough was unable to stand heel-to-toe and lost her balance several times. Before I instructed McCullough to begin, she started walking. McCullough missed heel-to-toe on steps 1-8. McCullough stepped off the line (to the left) on step 3. McCullough took 8 steps before stumbling to her right and turning improperly by spinning to her right. McCullough did not return back down the line and advised she was finished with the task.</p> <p>I then conducted the One Leg Stand task. When I advised McCullough to begin, she initially raised her right leg (bent at the knee like a flamingo) and almost immediately lost her balance placing her foot on the ground. McCullough then raised her left leg (again, bent like a flamingo), swayed, and placed her foot on the ground. McCullough alternated between lifting her left and right legs but was unable to stand for more than a few seconds before losing her balance and placing her foot on the ground. When 30 seconds had elapsed, I terminated the task.</p> <p>I next attempted the Finger to Nose task. I provided the instructions to McCullough multiple times and she advised she understood each time. Before beginning the task, McCullough demonstrated knowledge of the difference between her left and right hands. I provided the instructions to McCullough three separate times. McCullough would not tilt her head back or close her eyes when I told her to begin. When I called left, McCullough raised her left hand from her side and held her hand next to the side of her head, pointing to the sky. McCullough did not touch finger-to-nose and did not return her arm</p>

<p>to her side. I called right and McCullough raised her right hand (with her index and middle fingers extended), held it next to the side of her head, and did not return her arm to her side.</p> <p>Due to the fact that McCullough was obviously unable to follow simple instructions without either cutting me off or completely failing to do what I told her to do, I concluded that McCullough was too intoxicated to successfully complete the tasks. I placed McCullough under arrest for DUI and secured her in handcuffs behind her back which were checked for spacing and double-locked to prevent tightening.</p> <p>I transported McCullough to the Palm Beach County Breath Alcohol Testing Facility (BAT) where I conducted a 20 minute observation period to ensure she did not ingest or regurgitate. At the conclusion of the observation period, I requested McCullough provide a lawful sample of her breath for the purpose of determining the alcohol content. McCullough refused. I advised McCullough of Implied Consent (excluding the CDL portion of Implied Consent). McCullough talked over me almost the entire time. I attempted to ascertain whether or not McCullough understood the consequences of refusing to submit to a breath test. McCullough would not answer me and routinely requested to speak with her lawyer. I advised McCullough that she was unable to consult with a lawyer prior to making a decision on whether or not she would provide a breath sample. I requested McCullough provide a breath sample and called a refusal to submit at 0009 hours.</p> <p>I placed McCullough in a holding cell while I completed the arrest paperwork. The entire time McCullough was in the holding cell, she banged on the glass incessantly demanding a phone call to her lawyer. McCullough called me a "racist", accused me of "sniffing cocaine outside", "hooking up with the hookers because they're [law enforcement] pieces of shit", that I was "taking advantage" of her, told me to "suck my dick", and several times stated I was a "dick licking, ass sucking, piece of shit." McCullough also interpreted her behavior as "nice" and "kind" advising that she was entitled to a phone call despite the fact I had advised her several times that she could call her lawyer after I had completed the paperwork.</p> <p>I asked McCullough if she was willing to sign her citation for DUI and she refused. I advised McCullough that she would be committing a misdemeanor for refusing to sign a citation and she still refused. McCullough was so distracting with her routine knocking and shouting that I was forced to place her back in handcuffs. While restraining McCullough, I noted she had urinated on herself.</p> <p>Based on the aforementioned facts resulting from my investigation, I find Probable Cause exists to charge Naomia McCullough with DUI pursuant to FSS 316.193(1)(a) and Refuse to Sign/Accept a Citation pursuant to FSS 318.14(3).</p>

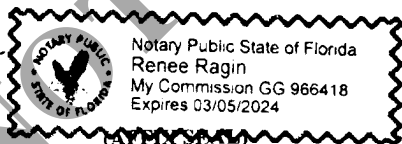
