Probable Cause

On May 4, 2021, I Trooper Warren Harty (4722) responded to a traffic stop that Trooper Marquis Gonzalez (1552) had made that involved a hit and run crash that I was working. The driver hit a Silver Toyota Pirus on the left rear side, and the front-end damages on the vehicle that Tpr Gonzalez stopped was consistent with the damages on the Toyota Pirus. The driver of the Toyota Pirus was able to provide a partial tag, (NZ73) prior to getting on the traffic stop. She then drove to the traffic stop and was able to confirm that the vehicle Tpr Gonzalez had pulled over was the vehicle that struck her.

When I arrived on scene on Interstate 95 (State Road 9) northbound @ 45Th St, I met with the driver Natalia Lee Tyring identified by her Florida Drivers license (T652-632-888-720). I questioned her about a hit and run crash that occurred northbound at Lantana Road. The victim called into the Lake Worth Regional Communication Center and provided the description of the vehicle which matched the vehicle that Tpr Gonzalez had stopped. I asked her if she was involved in the crash and she stated she wasn't involved in any crash. I then asked her for her driver's license which she was hesitant in providing. She finally complied and gave it to me.

When I went back to my vehicle and was working on the crash report, she began to walk away from the scene stating that she needed to use the restroom, we were currently on I-95 at that time. Tpr. Gonzalez gave her repeated lawful commands to stop walking away from the scene, which she refused to obey. She continued to walk away, walking towards the highway, so she was placed under arrest, and in the process, escorted to the ground without use of force and secured in handcuffs. She was taken into custody for obstruction without violence and hit and run without
