A CITIZEN CALLED IN REFERENCE TO A FEMALE PASSED OUT IN A BLACK BMW IN THE PARKING LOT OF 807 N MYRTLE AVE. THE CITIZEN WAS CONCERNED, SINCE THE VEHICLE HAD BEEN THERE OVER AN HOUR AND THE FEMALE HAD NOT MOVED.

UPON CONTACT, THE DEF WAS OBSERVED WITH HER FEET DRAPPED OVER THE PASSENGER SEAT WITH AN OPEN EMPTY BOTTLE OF SUTTER HOME MINI WINE BOTTLE AND SEVERAL UNOPENED ONES IN PLAIN VIEW. THE DEF WAS ALSO PANTSLESS AT THE TIME OF CONTACT, PASSED OUT WITH HER HEAD BACK. THE VEHICLE WAS RUNNING, IN PARK AND HAD THE KEYS IN THE IGNITION.

ONCE THE DEF AWOKE FROM HER SLUMBER, THE DEF SHOWED SIGNS OF IMPAIRMENT TO INCLUDE, GLASSY WATERY EYES, SLURRED MUMBLED SPEECH, AN ODOR OF A CONSUMED ALCOHOLIC BEVERAGE EMANATING FROM OR ABOUT HER PERSON AND WAS UNSTEADY ON HER FEET AFTER SHE ATTEMPTED TO EXIT THE VEHICLE.

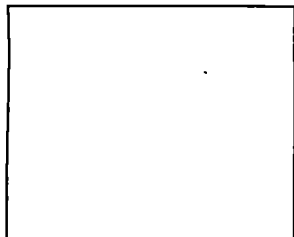
