The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On 11/06/2021, at approximately 2349 hours, Deputy K. Miceli (ABN 256117) was on proactive patrol and traveling on Boyette Rd, when she observed a running silver Honda Accord (FL tag: JQZB84), to be stopped in the middle of the roadway near Browning Rd. Deputy Miceli approached the Honda and made consensual contact with the defendant, who was sitting in the driver's seat of the Honda. Upon contact with the defendant, she had glassy eyes, unsteady balance and the distinct odor of an alcoholic beverage emitted from her breath as she spoke. The defendant was asked to participate in the Standardized Field Sobriety Exercises, which she agreed. During the exercises, the defendant showed signs of impairment and was placed under arrest for DUI. Implied consent (breath) was read and the defendant refused to provide a lawful sample of her breath. The defendant was positively identified via her Florida driver's license.
