On the above date and time, I responded to 718 NW 7th St Boynton Beach, FL in reference a disturbance.

Upon arrival, I made contact with [REDACTED] who provided the following sworn statement [REDACTED] advised her estranged husband W/M De Oliveira, Admilson (12/20/67) entered the home they both own with his girlfriend W/F Santos, Nathalie (1/12/90) with the intentions of using the restroom. Upon entering [REDACTED] requested they both leave to which Santos became upset. [REDACTED] advised Santos began shouting at her and was being escorted out by [REDACTED] this occurred [REDACTED] stated Santos began swinging her arms wildly and struck her with an open hand on her left cheek, scratching it. I observed scratches and blood to her face consistent with that statement (declined medical attention) [REDACTED] advised they then left the area in a white Toyota corolla.

BBPD Officers observed a vehicle matching the description in the area and conducted a traffic stop at 1300 W Boynton Beach Blvd Boynton Beach, FL which was positive for the involved parties.


Santos was then read her Miranda Warnings, which she advised she understood and was questioned about the incident. Santos stated she and [REDACTED] went to the residence in order for her to use the restroom, with an understanding that she had a cordial relationship with C.De Oliveira and she understood the relationship dynamic. Santos stated they made it to the front door but never entered the residence before being asked to leave by [REDACTED] Santos stated she never touched [REDACTED] and I observed no injuries to Santos.


Contact was then made with [REDACTED] who provided the following sworn statement. [REDACTED] advised the same statement as to why they went to the residence and stated they did enter before observing C.De Oliveira in a verbal dispute with Santos over her being there. [REDACTED] advised he stood between them as they began to shout at each other and confirmed Santos to swing her arms wildly before moving her out of the residence.

Based on the above, I find probable cause to charge Santos with Simple Battery in accordance with FSS 784.03(1A1)
