The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:
 On 7-4-2021 at approximately 1834 hours, Deputy T. Berg #206716 conducted a vessel stop for the purposes of completing a boating safety inspection. Your affiant and Deputy T. Berg did not observe any boating safety inspection decal(s) affixed to the vessel. Upon stopping the vessel, Deputy T. Berg made contact with the operator/defendant who was standing at the helm of the vessel and consuming an alcoholic beverage. During contact with the defendant, Deputy T. Berg observed him to have slurred speech, blood shot watery eyes and the distinct odor of an alcoholic beverage coming from his breath. Your affiant requested the defendant to perform Standard Field Sobriety Tasks (SFST's) to determine if he was fit to operate the vessel. The defendant agreed to the SFST's. Based on observations of impairment, your affiant placed the defendant under arrest for BUI. The defendant was advised of Florida Implied Consent and he agreed to provide a breath sample. The defendant provided a sample of 0.256 and 0.255. The defendant was identified verbally and via Florida DL: C-615-620-85-261-0.
