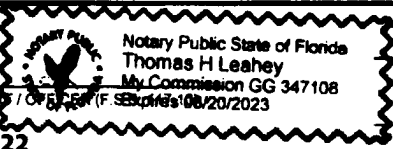
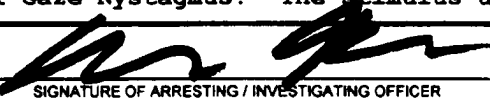

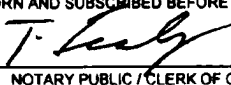

On 04/24/2022 at approximately 0112 hours, this Officer was conducting speed measurement enforcement in the area of the 10000-block of Alt A1A, PBG, FL, when a vehicle was observed traveling at an increased rate of speed south bound in the outside through lane. Body worn camera and in car video were used in the investigation. This Officer's initial visual estimation of the vehicle, was 65 MPH in a posted 45 MPH zone. Using RADAR Stalker DSR2X (DB001317), rear antenna (KR027120) this Officer received a steady tone and reading of 65 MPH. The RADAR calibration was last checked on 11/19/2021 and was due on 05/19/2022. Prior to this tour of duty on this date, this Officer ensured the RADAR was in working order, to confirm the accuracy of the unit. At the end of this tour of duty, this Officer did the same. This Officer received RADAR/LIDAR certification on 05/31/2008, in Cannon AFB, NM. This Officer entered the lane behind the vehicle and initiated a traffic stop on the vehicle, a Mercedes sedan (90AGHU/FL) on Alt A1A just north of Lighthouse Dr, PBG, FL. This Officer made contact with the driver, identified via Floirda Driver License photo, Neil Moureto (OF) while he was still in actual physical control of the vehicle. Moureto had slow slurred speech, bloodshot watery eyes, flushed red face and the strong obvious odor of an unknown alcoholic beverage emanating from his breath at conversational distance. This odor increased as Moureto spoke with this Officer. Moureto said he was coming from Jupiter Island and was on his way home. Moureto admitted to consuming two beers on this night. Based on this Officers observations, Moureto was asked to exit the vehicle to participate in Standardized Field Sobriety Exercises, to which he complied. Moureto said he did not have any medical conditions which would affect the exercises performed. The first exercise conducted, was the Horizontal Gaze Nystagmus. The stimulus used, was

a Toxoptix X3 with an illuminated red light. This Officer observed lack of smooth pursuit in both eyes and sustained involuntary jerking in both eyes at maximum deviation. This Officer also observed the onset of Nystagmus prior to 45 degrees in both eyes. The second exercise conducted, was the Walk and Turn. The line used was a strip of yellow tape placed upon the pavement by this Officer. During the instructions, Moureto stepped out of the starting position. During the first set of steps, Moureto raised his arms more than six inches from his sides and took eight steps rather than nine. Moureto conducted an improper turnaround by pivoting on both feet. During the return set of steps, Moureto again raised his arms more than six inches from his sides and stepped off the line on the sixth step. The third exercise conducted, was the One-Leg Stand. During the exercise Moureto raised his right foot. Moureto swayed considerably and raised his arms well over six inches from his sides. Based on this Officers observations, Moureto was placed under arrest at 0124 hours. During a search of Mouretos person incident-to-arrest two itemized receipts were located in Mouretos pocket. The receipts were from "Food Shack", the shorter receipt was dated 04/23/2022 at 2028 hours. The longer receipt from the same location had 12 alcoholic beverages purchased. The total purchase price was \$307.75 before tax. The longer receipt was seized as evidence and booked as same. At PBSO BAT, this Officer requested Moureto provide a breath sample for the purpose of determining its alcohol content, to which he agreed to do so. At 0219 hours, the instrument detected an Slope Not Met, thus a new 20 minute observation period was started again. At 0245 hours, he blew .200 and at 0248 hours, he blew .196. Based on the results of the investigation, this Officer has probable cause to prove Neil Moureto operated a motor vehicle, in the state of Florida, while under the influence of alcohol to the extent his normal faculties were impaired, with an unlawful breath alcohol content, in violation of FSS 316.193(1)(C). The degree to which Moureto was impaired by alcohol, was in violation of FSS 316.193(4).
