MARVIN MET WITH HIS LIVE-IN GIRLFRIEND NELLIN HERNANDEZ OF APPROXIMATELY THREE (3) YEARS, WITH WHOM HE SHARES A CHILD IN COMMON WITH. MARVIN ATTEMPTED TO ENTER THE RESIDENCE WHEN NELLIN BEGAN PUSHING HIM, ASKING HIM WHY HE IS ALWAYS DRUNK AND COMING HOME LATE. NELLIN SLAPPED MARVIN ACROSS THE FACE, AND BEGAN SCRATCHING MARVIN SEVERAL TIMES. MARVIN MANAGED TO ESCAPE AND IMMEDIATELY CONTACTED LAW ENFORCEMENT.</p> <p>I MADE CONTACT WITH NELLIN INSIDE THE APARTMENT. NELLIN STATED THAT ON TODAY'S DATE, MARVIN APPEARED AT THE RESIDENCE DRUNK. A VERBAL ARGUMENT ENSUED BETWEEN MARVIN AND NELLIN. NELLIN STATED SHE ATTEMPTED TO CLOSE THE DOOR SO MARVIN COULD NOT ENTER, WHEN HE FORCEFULLY PUSHED HE BACK.
