The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did
 On the above listed date, time, and location I observed a black Audi SUV bearing FL tag #927YKG
 (VIN:WA1DGAFE9FD032575) traveling westbound on Hillsborough Av. I visually estimated this vehicles speed to be
 approximately 65 MPH. I captured this vehicles speed with forward facing opposite direction in stationary mode at 64 MPH. I
 observed a steady doplar tone. There was no vehicles in front of this vehicle. I activated my emergency equipment to conduct
 a traffic stop on this vehicle. This vehicle passed multiple opportunities to pull over. I activated my spot light and pointed the
 spot light at this vehicle, in order for the driver to see my emergency equipment. This vehicle eventually pulled into the parking
 lot of a closed business. I made contact with the defendant. I observed signs of impairment to include bloodshot watery eyes,
 and the odor of an alcoholic beverage emitting from his breath. Post Miranda, the defendant admitted to consuming three 16
 ounce IPA beers while at the Hard Rock Casino. The defendant was asked to participate in the Standardized Field Sobriety
 Exercises, which he agreed. During exercises the defendant showed indicators of impairment. The defendant was placed
 under arrest for DUI. The defendant agreed to provide a lawful breath sample. The defendant completed a 20 minute
 observation period, and refused to provide a breath sample while in front of the intoxilyzer machine. The defendant was read
 Implied Consent in room CB-01, which he agreed to provide a lawful breath sample. The defendant completed a 20 minute
 observation period and provided two lawful breath samples (BAC .146/.162). The defendant was identified via Florida driver
 license.
