The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:
 On 3/26/2021 at approximately 0015 hours, the defendant was involved in a traffic crash with another vehicle. The defendant was operating a grey Nissan pickup truck bearing FL tag KSZF94 (VIN: 1N6AD0ER8KN751303) when he failed to stop and rear-ended the Jeep in front of him. The total damage was approximately \$1000. The defendant had bloodshot watery eyes, a strong odor of alcoholic beverage on his breath, unsteady on his feet, diminished fine motor skills and slurred speech. During the completion of the SFSE's, the defendant displayed several more indicators of impairment and was placed under arrest. Once at CBT, the defendant provided 2 lawfully requested breath samples of 0.219/0.212%BrAC after a 20 minute observation period. I issued the defendant DUI citation A3T9T5E for DUI over 0.150%BAC. The defendant identified himself via FL DL.
