THEY WOULD PLACE THE VEHICLE IN PARK AND REMOVE THE KEYS FROM THE VEHICLE PRIOR TO OFFICERS ARRIVAL ON SCENE. WHEN OFFICES ARRIVED, THE DEFENDANT HAD SLOW/SLOW BREATHING, UNRESPONSIVE AT ATTEMPTS TO WAKE HIM, AND HE HAD CONSTRICTED PUPILS. MEDICAL PERSONAL WOULD ADMINISTER NARCAN WHICH WOULD BE EFFECTIVE CAUSING THE DEFENDANT TO COME TO. WHEN AT THE HOSPITAL AND SPEAKING WITH HIM FURTHER, I OBSERVED HIM TO HAVE AN ODOR OF AN ALCOHOLIC BEVERAGE COMING FROM HIS BREATH ALSO AND HE SHOWED 6/6 SIGNS OF HGN. 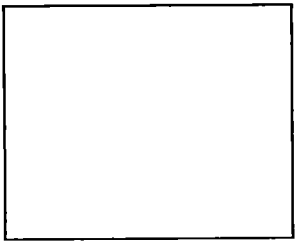
