at approximately 1:10 AM, at 11561 WALSINGHAM ROAD (AGING STILL BAR), in Pinellas County did:

THEN AND THERE THE DEF WAS AT THE AGING STILL BAR WHILE INTOXICATED. DEPUTIES HAD TO MAKE CONTACT WITH HIM AND TWO OTHER SUBJECTS WHO HAD PARKED A VEHICLE IN THE 7-11 PARKING LOT NEXT STORE WHICH WAS BLOCKING A CUSTOMER IN A PARKING SPACE. ALL THERE SUBJECTS WERE INTOXICATED. THE DEF WAS ARGUMENTATIVE. AFTER ALL SUBJECTS DENIED KNOWING WHO DROVE THE VEHICLE, 7-11 STAFF HAD THE VEHICLE REMOVED BY A WRECKER. THE DEF WAS THEN KICKED OUT OF THE AGING STILL. WHILE STILL ON THE PROPERTY OF THE BAR, THE DEF WAS SEEN ARGUING WITH THE MANAGER ABOUT BEING REMOVED, BECOMING LOUD AND ARGUMENTATIVE. THE DEF THEN BEGAN YELLING TOWARDS DEPUTIES WERE STANDING BY THE VEHICLE WAITING FOR THE WRECKER. THE DEF WAS GIVEN SEVERAL OPPORTUNITIES TO EITHER STOP BEING DISORDERLY OR TO LEAVE THE SCENE. DEF REFUSED WHILE CONTINUING TO CAUSE A SCENE ON THE PROPERTY OF A LICENSED ESTABLISHMENT.

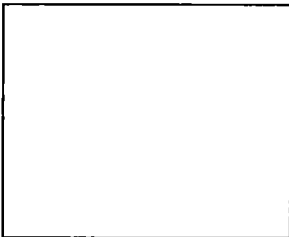
