I responded to Bar Louie, located on 1500 West Gateway Blvd, Boynton Beach, FL, in reference to a general disturbance. Boynton Beach Communications Personnel was advised by the manager that one of their patrons was exposing himself and threatening the staff.


On arrival, officers met with W/M subject in question, later identified as Nicholas John Grieco, who was outside in the south side area of the above business. Grieco was then detained (double locked and checked for spacing). A search of Grieco's person revealed that he was in possession of a black Taurus G2C 9MM (serial # TLR58554). The weapon was loaded with 12 rounds in the magazine and one in the chamber. The weapon was inside the right front pocket of Grieco's gray sweater and was not within a gun holster.

I then met with the manager, George Will, who advised that he had gotten into loud verbal altercation over Grieco showing part of his buttocks to other patrons who were sitting at the bar inside the business. At this time, Grieco used his chest to bump Will and then pushed Will in the chest with open hands. Prior to leaving the establishment, Grieco told Will "I'm going to come back with my boys and shoot up the place" and "he made a big mistake."

A visual inspection of Will's chest, face, neck, and person yielded no swelling, discoloration, bruising, or lacerations. I captured photographs of Will's person which were subsequently submitted to Digital Acquire. Additionally, Will declined medical attention. Will provided a sworn statement on my Body Worn Camera detailing the entire incident and was issued a case card. Contact was made with the bartender, Michael P. Falvey, who advised that he witnessed Will engaged in a loud verbal with Grieco in front of the outside bar. According to Falvey, Grieco then pushed Will while the two of them were in a disagreement.


Based on Will's statement and Falvey's statement, I find Probable Cause to place NICHOLAS JOHN GRIECO, under arrest for 1M count of simple battery in violation of 784.03.1A1 and 1M count of Simple Assault in violation of 784.011. A complete records check for outstanding warrants on Grieco yielded no active/extraditable warrants. Grieco was transported to BBPD for processing and later transported to PBCJ where he was turned over to PBCJ staff. The firearm was later submitted into BBPD evidence. The entire investigation was captured via body worn camera.

The foregoing instrument was sworn to or affirmed and subscribed before me
