The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:
 On 07/09/2021 at approximately 1820 hours, the defendant started a verbal argument with the victim inside the kitchen. The defendant would not let the victim leave and pressed his belly up to the victim's belly yelling in his face. The victim pushed the defendant to get away. As the victim walked away, the defendant grabbed the victim around his body and tackled him to the ground. The victim crawled to a chair in the living room at which point the defendant knowingly and willfully wrapped his right arm around the front of the victim's neck placing them in a headlock. The defendant released the victim after the witness struck him in the back of the head to get the defendant off of the victim. The victim and defendant were separated by the witness. The defendant attempted to physically assault the victim again but was unable to because the witness stood in between them. The defendant is the father of the victim. Both of them reside as a family unit at the incident location located at 19015 Fishermans Bend Dr. The victim positively identified the defendant as the aggressor based on their familial history. The defendant's identity was verified by his FL DL.
