Upon arrival, Officer Robichaud met with Wesley Aldred (W/M, 08/10/1987), who advised the following;</p> <p>Aldred stated that his girlfriend's ex-boyfriend, Nicholas Maiorino (W/M, 5-28-92) has been sending him harassing text messages and phone calls dating back to November of 2020. Aldred showed officers text messages that he has received from Maiorino telling him that he will find him anywhere and beat him until he was on his last breath. Some of the text messages included photographs of firearms with the message that both magazines are for Aldred, as well as voicemails left containing Maiorino shouting that he will kill Aldred.</p> <p>Aldred stated that on a previous occurrence, Maiorino came to their residence and began pounding on their front door. He expressed concern not only for his own safety, but his girlfriend Sydney Cooper (W/F, 09/21/1996) and her son, Brantly Maiorino (W/M, 07/18/2017). Aldred stated that he has to worry about his every action due to Maiorino living in such close proximity to their residence. It should be noted that Aldred has a protection order against Maiorino, however Maiorino had yet to be officially served with the order at the time of the original report.</p> <p>Aldred provided screenshots of the text messages he has received from Maiorino to Evidence.com. Aldred stated he did wish to prosecute and also was provided a victim's rights packet and was told to call Jupiter Police Department, should Maiorino come into deliberate contact with him or Cooper.</p> <p>On 03/28/2021, at approximately 1803 hours, Officer Robichaud responded to 1307 Arapaho St, in reference to a follow up for a previous Aggravated Stalking case (# 21-000672). Upon arrival, Officer Robichaud made contact with Wesley Aldred (W/M, 08/10/1987) and</p>

<p>Sydney Cooper (W/F, 09/21/1996) who advised that Cooper's ex-boyfriend, Nicholas Maiorino (W/M, 05/28/1992), has sent multiple text messages to Cooper's phone throughout the day.</p> <p>It was discovered that the proper spelling and date of birth is Nicholas Maiorino (W/M DOB: 05/28/1992), rather than what was provided in the initial report, which was spelled Mioriano.</p> <p>Aldred and Cooper stated that Maiorino has sent Cooper multiple text messages containing the following;</p> <p>At 0533 hours - A photograph of a black handgun, "I'm gunna off this nigha you don't know who I bang with", "I'll fuckin kill this dude I swear". At 0910 hours, "I'm gunna come lay some led on this nigha today", "I know where this nigha sleeps", "I'm coming with my boy Chase we gunna lite him up right now".</p> <p>Cooper later received text messages containing the address of 1200-1298 Seneca St and telling Aldred to meet him there at 8:45PM. Maiorino proceeds to say the following; "This is it fight to the death be there or be a fuckin bitch", and "Tell that bitch to step up". While on scene, Cooper received multiple text messages from Maiorino, as well as phone calls from him and a number with no caller ID; that she believed to also be him. Cooper took screenshots of the text messages, which were later submitted to Evidence.com.</p> <p>At approximately 2059 hours, while conducting routine patrol in the area of N Delaware Blvd, Officer Robichaud observed a Black Ford pickup truck parked and running on the corner of Ute St and Delaware Blvd. The vehicle was facing westbound with a clear view of Arapaho St. and Aldred's residence. The vehicle had an equipment violation due to its broken front windshield. Upon observing my patrol, the vehicle then began traveling deeper in to the neighborhood, as if they were to be lost. Officer Robichaud then observed the vehicle again on the corner of W Hawie St and N Delaware Blvd. Officer Robichaud conducted a records check on the temporary Florida License Plate of (CVP1078) as the vehicle headed south to W Indiantown Rd, which showed expired as of 01/15/2021 and with no vehicle information assigned. The registered owner of the vehicle was found to be Nicholas Maiorino (W/M, 05/28/1992).</p> <p>Officer Robichaud conducted a traffic stop on the vehicle at W Indiantown Rd and Delaware Blvd reference the above violations (Event# 21084682). Officer Robichaud made contact with the driver who was positively identified via Florida Driver's License as Maiorino. During the traffic stop, when Maiorino was asked where he was coming from and going. He stated that he was on his way home from the West Palm Beach boat show and was traveling to Wellington FL. Due to the location of the stop and observing Maiorino near the residence, the discrepancies in his story were questioned.</p>

When questioned about his reasoning's for being on Delaware Blvd, he stated he did not like the guy his ex was dating because his son is in the house. Maiorino also stated that he sent text messages stating that if he wanted to handle the situation, to come down the street and fight him. Maiorino gave consent for a search of his vehicle and no weapons or contraband were located inside. Maiorino was released from the scene with two Uniform Traffic Citations and was observed traveling westbound away from the area.

On March 1, 2021, I was assigned this case for follow-up investigation. I later called and spoke to Aldred about the case. Aldred told me he has a true fear that Maiorino could try to come to his house or confront him when he is out in the public due to his comments and actions to that point. The incidents that occurred above on March 28, 2021, further cement the case that Maiorino has been stalking Aldred and threatening him directly via text messages, emails and calls and to his ex- girlfriend Cooper, via text messages.

Based on the above facts, probable cause exists against Nicholas Maiorino for AGGRAVATED STALKING because he did willfully, maliciously, and repeatedly follow, harass, or cyberstalk (Wesley Aldred), and did make a credible threat as defined in Florida Statute 784.048(1)(c) to (Wesley Aldred) , contrary to Florida Statute 784.048(3). (3 DEG FEL)
