	Sydney Cooper (W/F, 09/21/1996) who advised that Cooper's ex-boyfriend, Nicholas Maiorino (W/M, 05/28/1992), has sent multiple text messages to Cooper's phone throughout the day.											
	It was discovered that the proper spelling and date of birth is Nicholas Maiorino (W/M DOB: 05/28/1992), rather than what was provided in the initial report, which was spelled Mioriano.											
	Aldred and Cooper stated that Maiorino has sent Cooper multiple text messages containing the following;											
ı	At 0533 hours - A photograph of a black handgun, "I'm gunna off this nigha you don't know who I bang with", "I'll fuckin kill this dude I swear". At 0910 hours, "I'm gunna come lay some led on this nigha today", "I know where this nigha sleeps", "I'm coming with my boy Chase we gunna lite him up right now".											
	Cooper later received text messages containing the address of 1200-1298 Seneca St and telling Aldred to meet him there at 8:45PM. Maiorino proceeds to say the following; "This is it fight to the death be there or be a fuckin bitch", and "Tell that bitch to step up". While on scene, Cooper received multiple text messages from Maiorino, as well as phone calls from him and a number with no caller ID; that she believed to also be him. Cooper took screenshots of the text messages, which were later submitted to Evidence.com.
