The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did The defendant was operating a white 2000 GMC pick up truck, Florida tag 65APIE. The defendant was stopped by TPD Officers J. Gonzalez (51251) and R. Williams (51210) for unlawful speed of 8 to 10 MPH over the posted speed limit and stopping beyond a painted white stop line at a red light. During the traffic stop the defendant's vehicle struck a raised curb. During his interaction with the defendant Officer Gonzalez noted signs of impairment to include the distinct odor coming from his breath, bloodshot and watery eyes, and flushed face. I responded to the scene in my capacity as a DUI Investigator. While talking with the defendant I could smell the distinct odor of an alcoholic beverage coming from his breath. The defendant's eyes were bloodshot, glassy, and watery. The defendant's face was flushed. The defendant stated he did consume two alcohol beverages tonight. The defendant was unsteady exiting the vehicle, and he had an upper body sway when standing. The defendant agreed to perform Field Sobriety Exercises. The defendant exhibited signs and clues of impairment, and based on a totality of the circumstances he was arrested for DUI. The defendant provided breath samples of .126% BrAC and .132% BrAC. The defendant was positively identified by his Florida DL.
