The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did The defendant was driving a silver 2011 Toyota Prius (FL TAG #BWBC41) northbound on Howard Av N in the center straight-only lane. Upon his entry to the Kennedy Bl W intersection, he abruptly turned left (westbound) in front of another vehicle, violating his right-of-way and almost causing an accident. The second vehicle was forced to immediately brake to avoid the potential accident. During the traffic stop for the infraction, the defendant was identified via a FL DL and exhibited several clues of impairment, to include: Watery/bloodshot eyes, blank/dazed stare, droopy eyelids, slurred/mumbled speech, fumbling fingers, slow/deliberate movements, sleepy/sluggish appearance, admitted to having a "few beers at MacDintin's" (a local bar in the Soho district), and emitted a distinct odor of an alcoholic beverage from his breath. He was arrested for DUI following a poor performance on SFSEs. While at CBT, he was read Implied Consent and provided 2 valid breath samples, measuring .106/.112 BrAC.
