



	<p>Last night, Nicolas had walked into his bedroom and found his wife; Sarah Shoopman (WF 6/20/80), and his realtor; Alexandria Springer (WF 8/11/90), in the bed engaging in sexual activity. Nicolas was very upset about the incident and left the bedroom. Nicolas stated he asked Sarah about the incident this morning and she claimed she did not remember the incident and became very violent. Nicolas stated Sarah began attacking him, scratching and hitting him. Nicolas sustained scratch marks to his chest, arm and face. Nicolas advised he did not touch or strike Sarah in self defense. Alexandria arrived back at the home at this time, and Sarah took her daughter, Harlow (WF 2/19/16), and left with Alexandria. Nicolas advised he did not know where they went but believed Alexandria lived in Abacoa. While speaking with Nicolas, he appeared to be under the influence of drugs or alcohol, as his speech was slow and slurred, and he was avoiding eye contact.</p> <p>A records check revealed that Alexandria resides 1587 Frederick Small Road in Jupiter. I responded to that location to attempt contact with Sarah.</p> <p>Upon arrival, I made contact with Sarah and Alexandria. Sarah was visibly upset and had obvious injuries; she declined medical assistance. Sarah provided the following statement:</p> <p>Last night Sarah was in her bed, making out with Alexandria, when Nicolas entered the bedroom and saw them. He became very upset and left. This morning Sarah asked Nicolas where he went, to which he replied "none of your fucking business". Sarah had a suspicion that Nicolas had been drinking again, after being sober for a few months, and she found vodka in the freezer. Sarah and Nicolas began arguing about the incident last night and Sarah went to leave through the front door. When she was trying to leave Nicholas pushed her down to the ground. While Sarah was on the ground, Nicolas continued to kick and punch her in the body and head. Sarah was able to get back up and ran across the street to her neighbors' house, Joy Wilt (WF 12/24/1962). Sarah advised Joy helped her bandage up the scraped on her knees from being pushed to the ground. Sarah texted Alexandria and told her Nicolas had hit her and that they had an argument. Sarah then returned to the home, and went into her bedroom. Her daughter, Harlow, was on the bed watching videos on her iPad. Nicolas then entered the room and began yelling profanities at Sarah; calling her a whore, among other things. Nicholas subsequently began punching Sarah, striking her in the face, arms and the back of the head. Sarah believes Harlow left the room at that time. Sarah tried to defend her-self, flailing her arms and scratching Nicolas. Sarah broke free and ran out of the house, and Alexandria arrived at this time. Alexandria went into the home, grabbed Harlow and left the residence. Alexandria left and returned to her home with Sarah and Harlow.</p> <p>Sarah had injuries consistent with her story. She had bloody scraped knees; scratches and bruises on her arms; bumps on the back of her head; and a swollen, bloody nose.</p> <p>Next I spoke with Alexandria who stated she was in bed with Sarah last night, when Nicolas walked in on them. She left shortly after. Alexandria had received text messages from Sarah this morning stating that Nicolas had struck her. Alexandria drove over to Sarah's to help, and took Sarah and Harlow back to her house. She showed me the text messages from Sarah from this morning, and stated she saw the injuries to Sarah. She helped Sarah clean up the blood on her face.</p> <p>Next I spoke with the neighbor, Joy, who advised she heard yelling and screaming coming from Sarah and Nicholas' home. Her husband was just leaving the house and said Sarah was running over. Sarah came in the house and said that Nicolas had just pushed her down and kicked/punched her. frantic state. Joy helped Sarah clean the wounds on her knees and covered them with bandages.

I returned back to 129 Via Zamora to speak with Nicolas, and asked him to go over the incident with me again. Nicolas told me his side of the story, although there were some discrepancies. He started by saying Sarah was freaking out at him because he confronted her about him walking in on her and Alexandria. He stated "Sarah said I should be fine with it, because it's girl on girl. And I said 'it's one thing if you include me, and it's another thing if you don't'". Ultimately, Nicolas was angry that Sarah and Alex did not invite him to join them. Nicolas said Sarah then got violent and began scratching him, and declined retaliating or putting hands on her. He stated he does not know how Sarah sustained any of her injuries.

He advised that when Sarah came back from the neighbors, the continued arguing on the front porch, however, when he was asked if they were arguing in the bedroom, he stated they were. When asked to clarify, he paused and did not seem to know how to answer the question. I asked if the argument started on the porch and went into the bedroom, and he replied yes. Nicolas denied that Harlow was in the bedroom. The more I spoke with Nicolas, the more he began to slur his words and change his story.

Based on the interviews and injuries that Sarah had sustained, I have developed probable cause to arrest Nicolas Shoopman for domestic battery-causing bodily harm pursuant to F.S.S. 784.03(1) whereas Nicolas Shoopman did actually and intentionally touch or strike Sarah Shoopman against the will of Sarah Shoopman and/or did intentionally cause bodily harm to Sarah Shoopman and Sarah Shoopman was a family or household member or a person in a dating relationship with Nicolas Shoopman contrary to Florida Statute 784.03(1) and 741.283.
