Responded to 71 Ocean Ave. (Marriott Ocean Point) in the incorporated town of Palm Beach Shores reference a disturbance in room 5209 and 5210. which are connected Upon arrival I met with security who accompanied to the room. Outside the room I could hear a female yelling from inside the room. I knocked on the door and made contact with W/F Betz, Nicole at the door of 5210 while D/S Clayton #28990 made contact with W/M Kelly, Ryan at the door of 5209. Betz and Kelly have been living together for the last 5 years and have a 4 year old daughter Addison Kelly together. Addison was present in the room with her mother Betz. Betz and Ryan are vacationing in Florida from Connecticut till Friday the 22nd. Betz stated that she had been arguing with Ryan who she states had been drinking since early this morning. Betz had also been drinking and both of them appeared extremely intoxicated. Betz stated that Ryan had threatened to shoot her in the face tonight and on previous occasions. Betz said that Ryans firearm was not with them and that it was in Connecticut. Betz claimed that Ryan had pushed her and punched her. I then spoke with Ryan who stated that Betz attacked him first by striking him in the face with a TV remote control and then attacking him. Ryan states that he defended himself and when able to locked himself in the other half of the hotel room until our arrival. Ryan had a visible cut to the bridge of his nose that was still bleeding during my interview with him. I the returned to Betz and asked her about hitting Ryan with the remote and she stated that she did after he threatened to shoot her in the face and prior to him pushing and punching her. I advised Betz that I was placing her under arrest for Domestic Battery a violation of FSS 784.03 (1a1). Betz was transported to PBADC for booking and processing.
