The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did

On the above listed date and time, at Charley's Bar, the defendant attempted to pay for her meal and drinks with a forged one hundred dollar bill. The one hundred dollar bill was lacking red and blue fibers, the security thread, and the watermark. The one hundred dollar bill also displayed what appeared to be a hand drawn image of Benjamin Franklin. Upon being detained, the defendant spontaneously stated she had "meth" (methamphetamine) within her purse. A pipe, commonly used for smoking methamphetamine, was located within the defendant's purse. A clear plastic container with a white, crystal-like substance was also located within the defendant's purse. The white, crystal-like substance tested positive for methamphetamine via a field reagent test kit. A small clear plastic bag was located within the defendant's purse. The bag contained half of an unknown light green pill, two halves of an unknown light blue pill, and an orange oval pill with the imprint "b 973 2 0." The orange pill was identified to be amphetamine and dextroamphetamine (20 mg) via drugs.com which is considered to be a schedule two controlled substance. The defendant was not in possession of a prescription for the previously listed medication. The defendant was identified as the person who uttered the forged one hundred dollar bill via the witness. The defendant was also identified via her Florida driver's license.
