On the 21st day of December 2020 at 0940 A.M. On December 21st, 2020, I was dispatched to 10062 Stonehenge Circle, Apartment 110, Boynton Beach, FL, 33437, reference domestic trouble. At approximately 0800, I made contact with the victim, Brooke Sanchez, and the suspect, Nicole Sanchez, reference a verbal domestic disturbance. Brooke and Nicole have been married for approximately one year and have lived together at the address listed above for approximately one year as well. This morning, Brooke knocked on Nicole's bedroom door to ask Nicole if she could use her phone as Brooke's phone is broken. Nicole would not let Brooke use the phone, causing them to have a verbal altercation. Brooke and Nicole both advised there was no physical altercation. As I interviewed Brooke and Nicole, I did not observe any injuries on them. I advised Brooke or Nicole to separate from each other for the day and Nicole left the scene with her son, Nikolas Smith. At approximately 0940, Nicole returned to her apartment, contacting PBSO again, requesting for a civil standby. Upon my arrival, I made contact with Brooke again and noticed redness on the right side of her eye and minor swelling. I asked Brooke what happened, who provided me with the following summarized statement. After units left the scene, Brooke went inside her apartment and started to clean. As Brooke was taking trash to the dumpster, Nicole returned to the scene. Brooke was ripping a wedding certificate, which she believes caused Nicole to be upset with her. Nicole confronted Brooke asking her why she was throwing away her documents. Brooke turned around to return upstairs into her apartment, which was when Nicole hit her on the right side of her face. There were also landscapers on scene, which Brooke advised witnessed the incident. I made contact with the landscapers, who refused to cooperate, but advise they only observed the end of the physical altercation between Brook and Nicole. I then spoke to Nicole, whose summarized statement is as follows. Nicole was sitting in her vehicle waiting for units to return when she observed Brooke carrying a box containing her belongings. Nicole exited her vehicles, while leaning against the driver door, and asked Brooke what was she doing with her personal belongings. Brooke asked Nicole where her debit card and work badge was, believing Nicole hid her belongings from her. Brooke tried entering the vehicle to search for her belongings, but Nicole refused her from doing so. I asked Nicole if she struck Brooke, or vise versa, which she advised no. I asked Nicole how Brooke sustained the injury to her face, as it was not there earlier when units were on scene, which Nicole advised she did not know. Due to the totality of the circumstances, I determined Nicole to be the primary aggressor reference the case at hand. The defendant, Nicole Sanchez, did commit the offense of simple battery (F.S.S. 784.03(1)(a)(1) - domestic-related) by actually and intentionally striking the victim, Brooke Sanchez, against her will, by striking her on the right side of her face. Photos were taken of both Brooke and Nicole, which were later uploaded to the PBSO domestic violence website. Brooke was provided with a PBSO domestic violence brochure and a case card. A PBSO level two domestic notification was also completed. Department of Children and Families were also notified, as Nicole's son, Nikolas, was on scene during the incident. Nicole's mother, Rori Smith, arrived on scene to take possession of Nikolas and Nicole's dog. This case is cleared by arrest.
